#### **Provisions for Season Pass Holders:**

- Season Golf Passes are based on an individual, couple, or family basis.
- 2026 fees will be for one year. New first time pass holders can join anytime for 1 year with 2<sup>nd</sup> year prorated.
- Annual fees and provisions are subject to change without notice.
- All golf pass holders are required to abide by the Rules and Regulations of Bear Creek Golf Club and to conduct them self in the proper manner at all times. Breach of these rules or any obstructive behavior could result in loss of all privileges.
- Pass holders are responsible for any damage done to person/property due to their actions.
- Golf passes are not transferable, non-refundable.
- Bear Creek reserves the right to limit starting times for pass holders to 2 per hour.
- Pass holders must show up for their tee times and have the number of players reserved. If not, a \$40.00 "no show" fee will be charged per golfer. Must cancel tee time 24 hours or more in advance.
- All pass holders must register in the pro shop before each round.
- Green fees are not valid during outside tournaments. Tournaments and Leagues sponsored by Bear Creek are valid for pass holders.
- Bear Creek reserves the right to close the course due to group outings, leagues, tournaments, course maintenance or bad weather conditions.
- Pass holders are responsible for seeing that guests get checked in and paid.
- All play must start on #1 or #10 at discretion of Pro Shop.
- Pass holders may not always get the tee times they want each day.
- Pass holders playing too fast may catch other golfers at times.
